Obedience Class Run Order

Utility B, Utility A

Open B (ODX/CDX), Open A (ODX/CDX), Open long sits and downs (*Open B & A may be combined*).

Novice B, Novice A, Novice long sits and downs (*Novice B & A may be combined*), Beginner Novice

Judge's choice for Utility & Open Patterns will be posted ½ hour prior to start of Obedience Trial.

Class run order may be changed at judge's discretion.

There will be no "FEO" (for exhibition only)

Obedience Awards & Ribbons:

1st thru 4th, Green Qualifying Ribbon

Awards: High in Trial, High Combined, HIT Junior.

Rally Class Run Order

Masters C, B, A; Excellent C, B, A; Advanced C, B, A; Novice C, B, A

Class run order may be changed at judge's discretion.

There will be no "FEO" (for exhibition only).

Rally Awards & Ribbons:

1st thru 4th, Green Qualifying Ribbon, Scores of 195 +, Dark Green X Ribbon, High Scoring Dog in the Regular Classes, High Combined Score in Excellent B & Masters B, Highest Scoring Jr. Handler in the Regular Classes

Day of Show: \$20.00; Juniors \$5.00

Exhibitors with dogs not registered with ASCA:

No dog without an ASCA individual registration, LEP number or ASCA tracking number may compete in any ASCA Obedience or Rally trial.

Get an ASCA Tracking Number by filling out the appropriate form on the ASCA website <http://www.asca.org> OR at the entry table on day of show.

(Fee to be paid directly to ASCA)

All exhibitors:

Get an ASCA Obedience and/or Rally Entry Form from the ASCA website <http://www.asca.org> OR at the entry table on day of show. (Fee paid to ASCRV)

No entry shall be accepted from a dog or handler disqualified from any ASCA program or a person not in good standing with ASCA.

Dogs **appearing** to show clinical symptoms of Distemper, Infectious Hepatitis, Parvovirus, Leptospirosis, kennel cough or other communicable diseases will be asked to leave the event, without refund of entry fees.

Bitches in season cannot be entered in Obedience and/or Rally

Ring location is outdoors on mowed grass.

Directions to show location

From I-5 north or south, take exit 55. From north, bear right at bottom of off ramp onto Grants Pass Parkway. From south, off ramp dumps directly onto Grants Pass Parkway. Once on Grants Pass Parkway, turn LEFT at lighted intersection (Agnes). Turn LEFT at stop sign (Foothill). Go 1.1 miles, then go straight onto Tom Pearce Park Road. After stopping to pay \$5 ark fee, go to first left into parking area.

There is a \$5.00 per car per day Parking Fee at the venue. The ticket box is in the parking lot. Each person is responsible for their own parking fees.
