Judge's choice for Utility & Open Patterns will be posted ½ hour prior to start of Obedience Trial.

Class run order may be changed at judge's discretion.

There will be no "FEO" (for exhibition only)

Optional Titling Class after conclusion of the regular classes: Beginner Novice

No dog without an ASCA individual registration, LEP number or ASCA tracking number may compete in any ASCA Obedience or Rally trial. Get an ASCA Tracking Number by filling out the appropriate form on the ASCA website <http://www.asca.org> OR at the entry table on day of show.  
(Fee to be paid directly to ASCA)

**All exhibitors:**

Get an ASCA Obedience and/or Rally Entry Form from the ASCA website <http://www.asca.org>  
OR at the entry table on day of show. (Fee paid to ASCRV)

No entry shall be accepted from a dog or handler disqualified from any ASCA program or a person not in good standing with ASCA.

Dogs **appearing** to show clinical symptoms of Distemper, Infectious Hepatitis, Parvovirus, Leptospirosis, kennel cough or other communicable diseases will be asked to leave the event, without refund of entry fees.

Bitches in season cannot be entered in Obedience and/or Rally

Ring location is outdoors on mowed grass.

**Directions to show location**

From I-5 north or south, take exit 55. From north, bear right at bottom of off ramp onto Grants Pass Parkway. From south, off ramp dumps directly onto Grants Pass Parkway. Once on Grants Pass Parkway, continue driving until you pass the hospital on the left (the road name changes to Redwood Hwy 199). Just past the fairgrounds on the right, veer to the right onto Redwood Avenue. Turn right on Willow Lane. Drive past Leonard Road to the driveway on the right with a sign on the fence that says "Schroeder Dog Park". If you get to the actual park/campground, you have gone too far.

**There is a \$5.00 per car per day Parking Fee at the venue. The ticket box is in the parking lot.  
Each person is responsible for their own parking fees.**
