### **Obedience Class Run Order**

Utility B, Utility A

Open B (ODX/CDX), Open A (ODX/CDX), Open long sits & downs (*Open B & A may be combined*).

Novice B, Novice A, Novice long sits and downs (*Novice B & A may be combined*).

Judge's choice for Utility & Open Patterns will be posted ½ hour prior to start of Obedience Trial.  
Class run order may be changed at judge's discretion.

Beginner Novice B & A Optional Titling Class after conclusion of the regular classes.

### **Obedience Awards & Ribbons:**

1<sup>st</sup> thru 4<sup>th</sup> – Green Qualifying Ribbon

Awards: High in Trial (in regular classes), High Combined in Open B & Utility, HIT Junior (in regular classes)

### **Rally Class Run Order**

Masters C, B, A; Excellent C, B, A; Advanced C, B, A; Novice C, B, A

Class run order may be changed at judge's discretion.

### **Rally Awards & Ribbons:**

1<sup>st</sup> thru 4<sup>th</sup> - Green Qualifying Ribbon, Scores of 195 + - Dark Green X Ribbon

Awards: High in Trial (in regular classes), High Combined in Excellent B & Masters B, HIT Junior (in regular classes)

### **Obedience Trial Entry Fees (each trial):**

\*Pre-Entry : (*refundable at Show Secretary's discretion*) Reg: \$18.00; Jr's: \$5.00

Day-of-Show: Reg: \$20.00; Jr's: \$5.00

(\*\*Entrants competing with the same dog in Utility & Open in the same trial pay \$5 LESS for the 2<sup>nd</sup> entry)

### **Rally Trial Entry Fees (each trial)**

\*Pre-Entry (*refundable at Show Secretary's discretion*): \$18.00; Juniors \$5.00

Day of Show: \$20.00, Juniors \$5.00

(\*\*Entrants competing with the same dog in Masters & Excellent in the same trial pay \$5 LESS for the 2<sup>nd</sup> entry)

**\*Pre-entry forms/payments accepted as of 3/15/21 and must be postmarked by 3/29/21.**

### **Exhibitors with dogs not registered with ASCA:**

No entry shall be accepted from a dog or handler disqualified from any ASCA program or a person not in good standing with ASCA.

Dogs **appearing** to show clinical symptoms of Distemper, Infectious Hepatitis, Parvovirus, Leptospirosis, kennel cough or other communicable diseases will be asked to leave the event, without refund of entry fees.

Bitches in season cannot be entered in Obedience and/or Rally

Ring location is outdoors on mowed grass.

#### **Directions to show location**

From I-5 north or south, take exit 55. From north, bear right at bottom of off ramp onto Grants Pass Parkway. From south, off ramp flows directly onto Grants Pass Parkway. Once on Grants Pass Parkway, turn LEFT at lighted intersection (Agness). Turn LEFT at stop sign (Foothill). Go 1.1 miles, then go straight onto Tom Pearce Park Road. After stopping to pay \$5 park fee, go to first left into parking area.

**There is a \$5.00 per car per day Parking Fee at the venue. The ticket box is in the parking lot.  
Each person is responsible for their own parking fees.**
